Digital Dictation

We have used Winscribe from Nuance since 2007 for digital dictation supported by Sound Business Systems. There is no record on file of the procurement method used at the time. It is not integrated with PAS or EPR. Winscribe is widely used across the DHB so no specific key stakeholder - Barry Morris CIO 027 443 3039.

Contract commenced 26th November 2007

The contract is evergreen and can be terminated with 3 months written notice

Annual service fee \$ 7300.00

Speech Recognition

We have trialled Dragon Medical One from Nuance as a proof of concept but have not expanded use across the wider DHB.

Telehealth functionality within DXC regional webPAS integrated with Microsoft Teams. Part of the greater webPAS contract and NZ Health agreement with Microsoft. Key internal stakeholder Alex Kemp- GM Allied Health 027 614 2123

We would like to see automated technical checks for the patient instead of the current manual process prior to a telehealth engagement.

EPR - The closest system we have to an EPR is our regional Clinical Portal from Orion Health

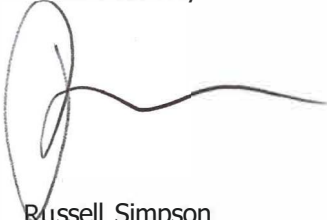
